The Twinning Fiche shall be circulated simultaneously to the 28 EU Member States in an invitation to submit proposals for its joint implementation. In addition, the project will support the beneficiary institutions in institutional analysis. In addition, and before the Twinning project will start, this contract aims to strengthen the institutional capacity of the Chamber in performance audit by providing training and one study tour to the SAI of an EU country.</p>
