Objective of the project:	<p><u>Global objective</u></p> <ul style="list-style-type: none"> The European Neighbourhood Programme for Agriculture and Rural Development in Georgia (ENPARD Georgia) aims to support the implementation of the Agriculture Sector Strategy of Georgia (2012/2020), in order to increase food production and to reduce rural poverty. <p><u>Specific objective</u></p> <ul style="list-style-type: none"> The purpose of this contract is to provide to a detailed review of the implementation of the Budget Support component of the EU Sector Policy Support Programme (SPSP) - ENPARD Georgia - and to provide consistent sets of conclusions and recommendations to be used by the Commission to make decisions on instalment disbursement for the third tranche of the budget support. The assignment will consist in a full-fledged and detailed review of the implementation of the EU budget support conditions. The assessment will take stock of the results achieved by Georgia's Authorities with regards to the Programme applicable indicators and recommendations on actions to be undertaken in case of mismatch between objectives and achievements is observed. In order to undertake the assessment, the consultant will analyse and gather, for each indicator, relevant documentation and data already at hand with a view to substantiating the instalment's payment request. As a result of this assessment, the Consultant will provide to the Contracting Authority recommendations as regards the level of disbursement for this tranche. The final report will include as annexes a macroeconomic assessment and a public finance eligibility assessment.
