Overview of the project:	<p><u>Overview of the assignment</u></p> <p>This assignment, which is divided into 4 Lots, comprises provision of i) four resident experts for the duration of the initiative and ii) a pool of experts to the MeHSIP II Programme for ad-hoc tasks as needs arise.</p> <p>i. The four resident experts will be based, respectively, in (i) Amman, (ii) Cairo, (iii) Rabat and (iv) Tunis, where EIB already has local offices (Cairo, Rabat and Tunis) and where it is planning to have one (Amman). The resident experts will support the MeHSIP team in Luxembourg in identifying and supporting the preparation for financing of key water, waste water and solid waste projects in the Southern Mediterranean region. They will report to the MeHSIP II team in Luxembourg and be in regular contact with staff in the EIB local offices.</p> <p>ii. The pool of experts will provide ad-hoc support to the four resident experts and to the MeHSIP II team based in Luxembourg, to whom they will report.</p>
