<b>Objective of the project:</b>	<p>The overall objective of the Ukraine Urban Road Safety Project (URSP) which this TA operation will be a part of, is to contribute to the National Transport Strategy 2030, the National Road Safety Strategy (NRSS), and the Road Safety Program (RSP) promoted by the Government of Ukraine. These national initiatives will in turn contribute to the United Nations Decade of Action for Road Safety and the Sustainable Development Goals for road safety worldwide. The URSP will achieve this through implementation of schemes related to urban road safety, better access to public transport and facilities for cycling and walking, and IT solutions for safe and effective traffic management.</p> <p><b>The purposes/specific objective of this contract</b> are as follows:</p> <ul style="list-style-type: none"> <li>to support effective implementation of the URSP; and</li> <li>to strengthen the capacity of relevant professionals to develop and implement appropriate road safety infrastructure schemes on urban roads in five cities in Ukraine (Kyiv, Lviv, Kharkiv, Odessa and Dnipro).</li> </ul>
<b>Qualifications required:</b>	<p><b>Qualifications and skills</b></p> <ul style="list-style-type: none"> <li>At least Bachelor degree or similar qualification in Traffic Engineering or other relevant field, a post graduate qualification would be an advantage;</li> <li>Fluent in English, good command of Russian or Ukrainian would be an advantage;</li> <li>Fully competent with common IT systems.</li> </ul> <p><b>General Experience</b></p> <ul style="list-style-type: none"> <li>At least 15 years' proven relevant work experience in implementing urban road safety infrastructure improvements;</li> <li>Prior 5 years' proven work experience in at least one transition economy<sup>1</sup>, experience in EU EaP countries<sup>2</sup> would be an advantage;</li> <li>Prior 3 years' proven work experience with IFIs.</li> </ul> <p><b>Specific Experience</b></p> <ul style="list-style-type: none"> <li>At least 10 years' proven work experience of streetscape design, safety engineering or traffic calming;</li> <li>At least 5 years' proven work experience of preparing and presenting training courses on road safety infrastructure issues;</li> <li>Proven work experience in a similar position in at least two similar projects (similar nature and similar size).</li> </ul>
