

EU Knowledge Hub Study Visit: “Exploring P/CVE Models in the EU and MENA Region: A Focus on the Jordanian Model”

19-20 November 2024, Amman, Jordan

Topic of the event

This 2024 EU Knowledge Hub (EU KH) MENA study visit will focus on the role of Prevention and Countering of Violent Extremism (P/CVE) models in EU Member States and MENA countries, with a specific emphasis on Jordan’s model of the ‘Community Peace Center’ (Al Markaz Al-Salem Al-Moujtamai) mandated with the implementation of P/CVE initiatives at the national level. The study visit aims to provide participants with an in-depth understanding of the Center’s multiple interventional axes and its engagement with state and non-state actors. Additionally, the study visit will explore other P/CVE models from both the EU and MENA, underlining effective practices in primary, secondary and tertiary prevention and multi-disciplinary collaboration among a broad network of local and regional actors/authorities in the field of prevention.

In summary, this study visit will facilitate discussions around the following key questions:

1. What are the key characteristics of the Community Peace Center’s P/CVE model in Jordan, and how do they contribute to its effectiveness?
2. Which aspects of the Jordanian model can be adapted to other EU and MENA contexts to enhance P/CVE efforts?
3. How can P/CVE models effectively address the intricate dynamics of drivers of radicalisation, implementing strategies that mitigate their progression towards violent extremism?
4. How can national P/CVE models and strategies support local prevention networks in developing intervention plans that strengthen social cohesion, promote inclusivity and reinforce community resilience against violent extremism?
5. In what ways can effective P/CVE models enhance strategic collaboration between the EU and MENA countries, fostering sustainable partnerships to address and counter violent extremism?

Participants

The target audience for this MENA study visit are:

- MS and MENA representatives responsible for designing/implementing prevention of violent extremism strategies, Ministry of Interior, Ministry of Justice or involved in the work done by national PCVE structures.

Format

The meeting is hosted by the Hashemite Kingdom of Jordan and organised with the assistance of the European Commission and the EU Knowledge Hub. It will be held in Amman, Jordan on 19-20 November 2024.

Participants are strongly encouraged to come to the event ready to engage, ask questions and discuss key ideas.
