## Training Opportunity for Newcomers in PCVE – Apply Today!

The European Commission, supported by a consortium led by the Danish consultancy NTU International, launched in June 2024 the EU Knowledge Hub on Prevention of Radicalisation.

### **ABOUT THE EU KNOWLEDGE HUB**

The EU Knowledge Hub on the Prevention of Radicalisation aims to support Member States in preventing radicalisation through a comprehensive, whole-of-society approach. This initiative will bridge the gaps between policymakers, practitioners, and researchers at EU level, fostering the exchange of knowledge and best practices.



## TRAININGS

These training sessions will kick off with four editions of the course **“Prevention and countering of radicalisation leading to violent extremism and terrorism for newcomers”**, taking place across different parts of Europe:

**Edition 1:** Northern Europe – Helsinki, 10 June 2025

**Edition 2:** Western Europe – Paris, 17 June 2025

**Edition 3:** Southern Europe – Athens, 24 June 2025

**Edition 4:** Eastern Europe – Warsaw, 9 September 2025

These courses aim to strengthen the European pool of practitioners, policymakers and researcher dealing with PCVE. Specifically designed for newcomers with less than 3 years of experience in the field of PCVE, the training will equip them with essential knowledge and practical insights to contribute more effectively to the prevention and countering radicalisation.



# WHAT YOU WILL GAIN

Each awareness-raising edition is a 1-day training (8 hours). After completing it, participants will be able to:

- Memorize the basic knowledge on radicalisation processes and assumptions of PCVE
- Identify early signs and risks factors of radicalisation
- Describe the EU's system of prevention of radicalisation, including the role of the EU Knowledge Hub
- Explain how the Hub can help to efficiently work in the PCVE field
- Understand the importance of early prevention
- Recognise the importance of multi-stakeholder collaboration in addressing radicalisation among various stakeholders in PCVE

Travel, accommodation and meals (breakfast, lunch and dinner) during the training will be organised and covered by the EU Knowledge Hub.

Each edition will invite 15 to 20 participants who meet the eligibility criteria listed below.

# ELIGIBILITY AND SELECTION CRITERIA

We are looking for early-career professionals who meet all the following criteria:

- Have less than 3 years of professional experience as a practitioner, policymakers, or researcher in PCVE.
- Are a citizen of an EU Member State, a Western Balkan country, or partner third countries (e.g. Norway and Switzerland). Important note: candidates with dual nationality, one from a Member State and the other from an eligible third country, may apply only once, using the nationality they consider most relevant.
- Have a good command of English (minimum CEFR level B2). Please check your level of English by following [this link](#).
