Policy Practice Joint Event on Victims of Terrorism

The EU Knowledge Hub on Prevention of Radicalisation is pleased to invite participants to the first-ever Policy Practice Joint Event (PPJE) dedicated to the topic of Victims of Terrorism (VoT).

This unique event brings together victims of terrorism, associations supporting them, and practitioners working in the field, alongside policymakers. It will provide a dedicated space for exchange, reflection, and joint learning on how to strengthen responses, support systems, and policies addressing the needs and rights of victims of terrorism.

This one-day event is designed to foster dialogue between practice and policy, ensuring that the perspectives and experiences of victims and practitioners directly inform ongoing work at the EU level. Participants will also gain insights into the latest developments, tools, and practices supporting victims of terrorism, while contributing their expertise to shaping future approaches.



EVENT CONTENT OVERVIEW

Participants will engage with a range of formats that might include presentations, panel discussions, and interactive Q&A sessions. The event will provide an opportunity to share experiences, discuss support systems and best practices, and explore ways to enhance the recognition of victims of terrorism and their involvement in the prevention of radicalisation, as well as to foster cooperation among their associations at EU and national levels.

- Be a citizen of an EU Member State.
- Be working in, or directly engaged with, the field of victims of terrorism, either as a victim, association representative, or practitioner.
